LOFC SAVINGS ACCOUNT E-STATEMENTS / SMS / EMAIL ALERTS / DIALOG TOP UP

I/We hereby authorize and request you to make available service of receiving E-Statements / SMS / Email Alerts & Dialog Top- Up Services on my **LOLC FINANCE PLC** (hereinafter referred to as "LOFC") Savings Account.

In consideration thereof I/We understand, undertake, authorize, consent and agree as follows.

- LOFC Savings Account E-Statements / SMS / Email Alerts & Dialog Top- Up service facility is for personal use only.
- I/We shall register with LOFC my/our mobile phone number & email address and/or any other information LOFC may require for the provision of this service to me as may be requested by LOFC. I/We understand that LOFC will act based on the details and documents already provided to LOFC by me/us and LOFC shall not be held liable for any misrepresentations on my/our part.
- In the event I/we change my/our mobile phone number/email address, I shall inform LOFC immediately and I/we agree that LOFC shall not be held responsible in an event I/we failed to inform any such changes in prescribed time period.
- 4. I/We agree to inform LOFC in an event if I/we lose our mobile or suspects of a possible third party activity and LOFC shall terminate/ deactivate the E-Statements/SMS/e-mail alert & Dialog Top-Up service as deemed necessary. - I/we accept and agree that, LOFC shall not be held for any losses or damages caused in Dialog Top- Up service due to any delay or failures occurred on the part of Dialog,
